Flint Hills League Update: Jay Doornbos

- Alma-Wabaunsee asked for membership in the league.
- Do they plan to play 11-man football?
- Will they play us in every sport?
- Council Grove wouldn't vote yes if another school left the league.
- Will join the league in the 2024 2025 season.
- Central Heights will be leaving the league at the end of this season. Will be joining the 3-Rivers League. Concerns Council Grove as we're vested in maintaining the status of The Flint Hills League. Tough on scheduling for Middle School Football as the numbers diminish in football.
- The league made a concerted effort to raise the prices to pay officials. Some league schools aren't covering the cost of officials and workers as prices raise. There was a \$5.00 raise in the cap for a Family to \$20.00.
- The Flint Hills League wants to charge for baseball, softball, and track. Council Grove is opposed to this course of action.
- Could move to not allow a 6th grade student or below grader to enter a sporting event without being accompanied by an adult.
- Legislation passed the Fairness in Women's Sports Act. Can only compete in a sport within your biological gender at birth.
- Baseball is allowed pitchers and catchers to work with their school coach, out of season.
- Homeschool Students can compete in your home district only. Homeschool students must be in a registered curriculum from KSDE. Homeschool students will be in a eligibility system run through KSHSAA.

Action Items:

RFP 2024-002: Remove and Replace Windows at CGES and CGJSHS:

Terry Powell (Billy Glenski) moved to accept the bid of \$281,270.59 for the CGJSHS North Elevation Windows with Ben Moore completing a change order request to ensure proper expenditure of funds at CGES and CGJSHS. Motion passed 6-0.

Policy Update: EE – Food Service Management:

Jamie Johnson (Billy Glenski) moved to accept the verbiage change to the current Food Service Policy in EE and EE-2:

"Students may charge no more than 5 meals to this account."

"Students who have charged the maximum allowance to this account and cannot pay out of pocket for a meal will be provided an alternate meal."

"At least one notification shall be provided to a student and his/her parent or guardian prior to denying meals for exceeding the district's charge limit."

Motion passed 6 - 0.

2023 – 2024 Proposed Food Service Pricing

Mary Kay Myers (TinaRae Scott) moved to accept the 2023 – 2024 meal prices as Universal Free Breakfast, Pre-K thru 6th Grade Lunch = \$3.20, and 7th Grade thru 12th Grade Lunch = \$3.30.

Proposed Parking Passes at CGJSHS (Presented by Jay Doornbos):

Jamie Johnson (Billy Glenski) moved to approve proposed parking passes to teachers and students at CGJSHS to assist the School Resource Officer, Admin Team, and Behavior Teacher in identifying vehicle owners.

Proposal to Allow Admission for Immediate Family Members of USD 417 Employees Free Entry to Events With Their Staff Badge at the admission site:

Terry Powell (Jamie Johnson) moved to allow free admission for immediate Family members of USD 417 Employees at all USD 417 sponsored events by presenting their Staff Badge at the admission site.
